- 1. The DSSSB vide its Advertisement No. 03/2013 with closing date 18/10/2013 had advertised 345 vacancies (UR-174, OBC-93, SC-52, ST-26 including EXSM-31, OH-04, VH-03, and HH-03) for the post of Lower Division Clerk in Municipal Corporation of Delhi, under Post Code 51/13. Board Conducted Tier-I written examination for recruitment in respect of this post on 24/10/2019, 25/10/2019 and 23/02/2020.
- 2. The normalized marks obtained by **14177** candidates who have duly appeared in written examination (online mode in multiple shifts) held on **24/10/2019**, **25/10/2019** and **23/02/2020** have been uploaded on Board's website. Candidate can view their marks by logging into their account in the OARS Module www.dsssbonline.nic.in.
- 3. The candidate having **Roll No. 11210601406** belongs to OBC outsider thus has been considered in UR category. The candidate is over age in UR category therefore candidate not shortlisted for appearing in Skill test.
- 4. Based on the performance in Tier-I written examination (online mode), out of these 14177 candidates, total 2763 (Two Thousand Seven Hundred Sixty Three) candidates (UR-1357, OBC-737, SC-409, ST- 208, EXSM-15, HH-02, OH-32, and VH-03) as detailed below, have been provisionally shortlisted to appear in Skill Test/Typing Test as per policy of the Board subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms. The shortlisted candidates shall be called for Skill Test/Typing Test separately.

5. Only those candidates have been considered in OBC Category who has declared that they had obtained their caste certificates from Delhi State in their online examination form.

- 6. Since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates qualifying for appearing in Skill Test/Typing Test does not entitled them any right over the post.
- 7. Reserved Category candidates who have obtained marks above or equal to the last shortlisted UR Candidates have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR category, subject to availability of vacancies, otherwise for selection in their respective category.
- 8. As per the Board Notice dated 26/04/2013 the minimum qualifying marks in one Tier written examinations for UR Category Candidate is 40%, for OBC Candidate is 35% for SC/ST/PH candidate is 30%.
- 9. The qualified candidates for appearing in Skill Test/Typing Test have been called as per policy of the Board of the advertised vacancies; however all the candidates who have score marks equal to the cut off marks in each category have been shortlisted.
- 10. The details of skill typing test shall be notified separately by the Board. The candidates are hereby advised to check the website of the Board regularly.
- 11. The short listing of candidate is subject to the outcome of the court cases, if any, pending in various courts related to this post.
- 12. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
