Notice for Document Verification & Biometric Verification of provisionally selected candidates for the post of Wildlife Guard/Game Watcher, Department of Forests & Wildlife, Govt. of NCT of Delhi.

The candidates who have provisionally qualified the Computer Based Test (CBT) for the post of Wildlife Guard/Game Watcher in the Department of Forests & Wildlife, Govt. of NCT of Delhi, as declared vide result notice no. F.No 1(39)/DCF(HQ)/Estt./Rect.-EdCIL/2019/2744-52 dated 04.09.2020 are now required to appear for document verification and biometric verification.


It shall be mandatory for the provisionally selected candidates to appear at the time of document and identity verification with the following original documents along with one self-attested Photostat copies of the same and two attested passport size photographs on **9th October, 2020** for the purpose of verification of his/her original documents:-

- (i) System generated printout of application with candidate's scanned photograph and signature.
- (ii) Proof of application fee receipt.
- (iii) Certificate/Marks-sheet of Secondary School Exam in which date of birth of the candidate is indicated.
- (iv) Degrees & Certificates of all educational and professional / higher qualification, along with marks-sheet of all years/semesters, if any.
- (v) Certificate/proof of SC/ST/OBC/Ex-servicemen/EWS etc., as the case may be, issued by the concerned Competent Authority. (If applicable)
- (vi) Candidates already employed with Govt. Departments/PSU/Autonomous Bodies will have to produce 'No Objection Certificate (NOC)' from the employer at the time of Joining Service, if offered appointment.
- (vii) Aadhaar Card, if not issued then registration slip for Aadhaar.
- (viii) Identity proof such as Voter ID Card, Passport, Driving License etc.
- (ix) All other documents, as per details given in the advertisement and/or call letter.
