**RECRUITMENT TO THE POST OF FOREST RANGE OFFICERS IN A. P. FOREST SERVICE NOTIFICATION NO.10/2018 (GENERAL RECRUITMENT)**

**RESULT NOTIFICATION**

It is hereby informed that on the basis of the Written Main Examination (Computer Based Test) held from 17/03/2020 FN & AN to 19/03/2020 FN to the post of Forest Range Officers in A.P Forest Service vide Notification.No.10/2018, Dt: 04.12.2018, the Candidates with the following Registered Numbers have been provisionally admitted in 1:3 ratio duly considering category wise merit for Walking Test, Medical Examination and verification of Original Certificates. The results are available in the Commission's Website <https://psc.ap.gov.in>.

The date, time and place of Walking Test, Medical Examination to the eligible Candidates will be communicated separately. The Candidates should produce a Medical Certificate issued by a Medical Officer not below the rank of Civil Assistant Surgeon at the time of Walking Test failing which they will not be allowed for Walking Test.

**Those who are qualified in the Walking Test and Medical Examination are eligible for verification of Certificates. After verification of the Original certificates, Computer Proficiency Test will be conducted in terms of Commission's Notification No.10/2018.**

The Candidates provisionally admitted for verification of certificates are required to produce the Original Certificates relating to **Age (SSC), proof of Age Relaxation, Qualification as mentioned in the notification, Study Certificate, Integrated Community Certificate in case of reserved candidates, Certificate of exclusion from Creamy Layer in case of BCs** obtained from revenue authorities in terms of G.O.Ms.No.3, Backward Classes Welfare (C2) Dept., Dt: 04.04.2006 read with G.O.Ms.No.26, BC Welfare (C) Dept., Dt: 09.12.2013, **Migration Certificate** for candidates who migrated from Telangana to Andhra Pradesh at the time of verification of Original Certificates, if the candidates fail to submit requisite certificates on the date of verification or they fail to submit the required/conformable with the particulars furnished by him/her in the Online application form, shall be treated as ineligible. The results of such candidate (s) shall be cancelled at any stage in the process of selection. The Commission has the right to disqualify any candidate, if he / she is not found eligible for any reason.
