**TSPSC Group 2 Eligibility Details:** Telangana State Public Service Commission (TSPSC) Goup-II Services eligibility details for the following posts are given below...

- 1. Municipal Commissioner Gr-III (Municipal Administration Sub Service)
- 2. Assistant Commercial Tax Officer (Commercial Tax Sub-Service)
- 3. Sub-Registrar Gr-II (Registration Sub-Service)
- 4. Extension Officer (Panchayat Raj and Rural Development Sub Service)
- 5. Prohibition and Excise Sub Inspector (Excise Sub-Service)

## Eligibility Criteria:

**Age limit:** Candidates age should be between 18-44 years for Municipal Commissioner, Assistant Commercial Tax Officer, Extension Officer, 20-44 years for post Sub-Registrar, 18-28 years for Prohibition and Excise Sub Inspector.

Age Relaxation: The upper age limit prescribed above is however relaxable in the following cases:

S.No	Category of candidates	Relaxation of Age Permissible
1.	Retrenched temporary employees in the State Census Department with a minimum service of 6 months	3 years
2.	Telangana State Government Employees (Employees of TSRTC, Corporations, Municipalities etc., are not eligible).	5 years based on the length of regular service
3.	Ex-Servicemen	3 years & length of service rendered in the armed forces
4.	N.C.C (who have worked as Instructor in N.C.C)	3 years & length of service rendered in the N.C.C
5.	SC/ ST and BC	5 years
6.	Physically Handicapped persons	10 years

**Educational Qualification:** Candidates should possess Bachelor's Degree from any recognized University in India established or incorporated by or under Central Act, Provincial Act, a State Act or an Institution recognized by the U.G.C. or an equivalent qualification.

For Prohibition and Excise Sub Inspector: Physical Measurements are also required as indicated below. For Men:

- 1. Must not be less than 165 Cms. in height.
- 2. Must not be less than 81 Cms. round the Chest on full expiration with a minimum expansion of 5 Cms.

## For Women:

- 1. Must not be less than 152.5 Cms. in height.
- 2. Must not weigh less than 45.5 Kgs.

## Visual Standards for Prohibition and Excise Sub Inspector:

- 1 Right Eye Near Vision 0.5 (Snellen), Distant 6/6.
- 2. Left Eye Near Vision 0.5 (Snellen), Distant 6/6.
- 3 Each eye must have a full field of vision.
- 4. Colour blindness, squint or any morbid condition of the eyes or lids of either eye, knock knees, pigeon chest, flat foot, varicose veins, hammer-toes, fractured limbs or decayed teeth shall be deemed to be disqualification.
