NOTICE

With reference to Samiti's notice No.20108 dated 03.12.2021, candidates who qualified the skill(typing) test held on 16.09.2021 were called for verification of documents/ eligibility criteria for the post of LDC w.e.f. 27th December, 2021 to 31st December, 2021 at Navodaya Vidyalaya Samiti (HQ), B-15, Institutional Area, Sector 62, NOIDA, Distt. Gautam Budh Nagar (U.P.). Out of 433 candidates, 400 candidates were reported and 33 candidates were reported absent.

Samiti has decided to extend another opportunity i.r.o. these 33 absentee candidates for verification of documents/ eligibility criteria for the said post. They were requested to report on **29.01.2022** at **Navodaya Vidyalaya Samiti (HQ), B-15, Institutional Area, Sector 62, NOIDA, Distt. Gautam Budh Nagar (U.P.)** at **9:00 AM** for the said purpose. A list of these 33 candidates is also appended herewith for information to all concerned. All the said candidates concerned are requested to attend the documents verification on the said scheduled date alongwith their requisite original certificates as well as one set of self attested photocopies of the certificates as mentioned in their call letter issued earlier for document verification.

It is apprised that no separate call letter/intimation in this regard will be sent to the candidate concerned by this office.

It is further apprised that the candidature of the candidate(s) for the said verification is **purely provisional** and does not confer any right to the candidate(s) for selection/appointment to the said post in this organisation.

Keeping in view the COVID-19 pandemic situation, candidates are instructed to strictly follow the below mentioned guidelines while attending the verification at venue on scheduled date/time of verification:

1. Wearing of mask to cover the mouth and nose.
2. Wearing gloves.
3. Should bring own transparent water bottle & hand sanitizer.
4. Should not share any of his/her personal belongings/material with any other candidate.
5. Should maintain safe social distancing with one another during verification of documents.
6. Must have Aarogya Setu App installed on his/her mobile phone. The Aarogya Setu Status must show candidates's risk factor. In case a candidate does not have a smart phone, he/she will have to bring in a signed declaration (mentioned at end of the notice) to this effect and show it at the venue, if requested.
7. Only candidate is allowed at the venue of the verification. However, in case of PH candidate, an attendant is permitted.
